I UNDERSTAND THAT:

1. It is necessary to pay \$450 and that a \$200 non-refundable payment is to be made with this application and the balance to be paid on the first day of class. If full payment is not completed by the last day of the scheduled class then the student will be recorded as a Failed Applicant. Make checks payable to Richardson's Safe Driving School. We accept cash, check or Vemno (@Becky-Ruether) (last digits of my phone are 8052.)
2. Course requirements: Students must be a minimum of 15 years of age as of the first day of the session. In accordance with the DOL policies, RSDS "refus[es] to allow a student to attend a driver training education course before the age of fifteen years." The minimum/maximum course duration is no less than 30 days and extended no further than one year past the start date of the student's session.
3. Refunds will NOT be granted for "dropping" the class after the initial 6 hours, expulsion, or failing the class for any reason.
4. No students will be enrolled in the class after the first three sessions (6 hours of classroom instruction) have been completed.

5. The student is required to drive at least 50 additional hours, 10 of which are at night, outside of class with a parent/guardian.

6. The student must bring his/her Washington Instruction Permit to every Behind the Wheel (BTW) lesson. To cancel a pre-arranged BTW lesson, the student must notify the instructor at least 24 hours in advance. If the student does not bring a driving permit, does not bring required glasses/contacts, does not appear for a scheduled drive, or does not notify the instructor within 24 hours, he/she will pay \$35.00 cancellation fee PRIOR to the next drive.

8. All classroom assignments and tests must be complete and correct before credit is given. The instructor gives answers to all assignments prior to collecting each assignment.

9. Any classroom assignments/tests that are not complete and correct by the student's last scheduled class will constitute a \$25 fee for time spent re-grading until assignments/tests are complete and correct.

10. Parent Night–The first hour of the first class session requires a parent or guardian to be present to receive information on intermediate license laws, restrictions, and sanctions (RCW 46.20.075–see attached). Included in the orientation will be Target Zero, organ donation and a parent guide to teen driving and responsibilities and importance of parent involvement with the student. Questions are more than welcomed at any time!

11. Your student must have a WDL number. Go online to DOL.WA.GOV website, go to "LicenseXpress" and receive an ID number. Then include that number on the Permit Line above. Once we have the application, down payment and ID number, we will record it onto the DOL website. The student may go to the DOL and receive the permit no sooner than 10 days before class starts. Remember to have a parent there and proof of identity (birth certificate, etc.).

By signing, I agree I have read and understood the IDL requirements, restrictions, and penalties information (RCW 46.20.075).
